witnessing requirement (PACs, MPM and regulatory body) as per stipulated in PPGUA.


Fun Facts



Duyong and Resak Condensate Metering System Upgrade FAT (26 Feb – 3 Mar 2020)



The FAT covers the functional tests and calculations for the Coriolis metering system, quality measurement instrumentation and HMI modification.

IRIS User Training and Roll Out for MCOT and BCOT MTAB (14 – 16 Jan 2020)



IRIS has successfully rolled out for MCOT and BCOT Crude MTAB, starting with January 2020 closing. The session was held

at PCSB SK Oil office for SK Oil and SSB. PAC will submit IRs in IRIS and the corrected production figures will be pushed to HyPAS daily input upon approval by MPM HAA.

Virtual IRIS User Training and Roll Out for LGAST and SBGAST MTAB

The user training sessions were conducted virtually to LGAST and SBGAST Customers, PTTEP and PCSB SBA on 20 March, 2 April and 20 April 2020 respectively.

Despite of MCO, IRIS has successfully rolled out for LGAST and SBGAST MTAB, starting with March 2020 closing.

SBGAST HMA Assurance Program (13 – 17 Apr 2020)

PETRONAS successfully conducted a virtual desktop assessment for SBGAST allocation network including five metering systems (RP1, RP2, SBPC, SEC and Condensate Station).

PCSB SBA have given their utmost commitment attending assessors' requests and queries. The virtual execution of this Assurance Program demonstrates Focused Execution for everyone involved.



EC Version 12.2 Demo by TietoEVRY (11 Mar 2020)

MPM HMA organised a demo session for EC12.2 update. The session attended by MPM-HMA, GTD-PD&T, and TietoEVRY and was broadcasted live by Tieto-EVRY in Norway and TietoEVRY Malaysia

representative. The session provides an insight on the update and its features.

Note: In Nov 2019, EC has release an update of EC12.2 version to introduce and integrate all 3 modules (KeyCloak, Yellowfin, ECIS Agent) and will be standard installation post EC12.0 version.

Measurement and Allocation Activities Waiver during MCO

PETRONAS released a letter to waive the requirement for the following activities summarised below:

- Metering validation, meter proving and prover recertification
- Sampling and analysis
- Independent surveyor witnessing for inventory and offtake

PAC is required to ensure all measurement system is available and reliable at all time by monitoring metering system performance via all possible method (e.g. diagnostic tool, historian, etc).
